As from the 1st July 2011, I can no longer take cheques - even with a cheque guarantee card - as many banks have now informed their customers either that cards issued in the future will not guarantee cheques or that currently issued cards (e.g. debit cards) are no longer valid to guarantee cheques. All cheques will therefore have to be treated as having no guarantee card and a waiting period of 10 days would be required to process cheques before instruments are handed over. In addition to which there is an administration charge of £25 for special special clearance.

## **Disposal of Uncollected Goods**

The Torts (Interference with Goods) Act 1977 provisions apply any time after the goods are ready for collection, subject to any terms imposed at the time the goods were left with GT Services out for repair/service. The Customer is under an obligation to collect their goods worked on or left for assessment. GT Services is entitled to sell the goods if they remain uncollected. Owners will be notified in writing and a storage charge may be applied if no arrangement to 'store' has been agreed beforehand. The proceeds of a sale, less monies owed to GT Services, including the cost of the sale (e.g. advertising) admin. and storage, will be sent to the owner of the goods.
